- 2. A candidate must have their principal place of residency in the Hawke's Bay Power Consumers' Trust district.

  This means a candidate must be on the parliamentary roll at an address within the Trust district
- 3. A candidate and their nominator must be a consumer of electricity under the Unison Network Ltd lines network and they must be on the Consumers Roll for the 2024 Hawke's Bay Power Consumers' Trust election.
- 4. Candidates are encouraged to provide a profile statement of no more than 150 words for inclusion with the voting documents. This can be provided as a Word document/file and submitted with the nomination paper.
- 5. Candidates are also encouraged to include a recent, colour passport-sized photograph for inclusion with the voting documents. This should be of the candidate only and taken within the last 12 months. If emailing, this should be as a high resolution .jpeg or .jpg file.
- 6. Each nomination <u>must</u> be accompanied by a nomination deposit of \$100 (incl GST), payable by bank transfer (see below for more details) or cash . The nomination deposit shall be refunded if the candidate receives not less than 10% of the votes cast.
- Nominations close at 5pm, Wednesday 31 July 2024.
   Nominations of candidates must be in the hands of the Returning Officer or an Electoral Official by this time.
